- 3) Whereas the above named Trustees propose to promote several institutions beneficial to the general public in the name of Swami Vivekananda.








4) All institutions including Vivekananda Public School now functioning under the control of the above named Trustees shall hereinafter, be under the management of the Board of Trustees from time to time elected by the General body of the SVECT. The Trustees shall within one year from this date, purchase minimum TWO acres of land surrounding Piravom and construct suitable building for the functioning of Vivekananda Public School for getting approval and recognition of Central Board of Secondary Education.

5) The Board of Trustees constituted as per clause four above shall consist of 11 members elected for a period of 3 years from among the General Body of Trustees. The day to day functions the entire administration and management of the Trust and its institutions shall vest in the Board of Trustees.

6) There shall be maximum 40 Life members in the Trust. The remaining 6 members shall be incorporated within a period of one year from this date. Otherwise the incorporated number of Trustees as on that date together with the above 34 numbers of settlers shall constitute the maximum life Membership in the Trust. This trust Deed is a part of a Trust Deed registered as No.28/2004 book IV Volume 66 pages 27 to 33 of Sub registry Office Piravom this deed is registering for adding the numbers of the Trustees.

7) In case of any vacancy that may arise by death, by disclaim or incapacity or otherwise the said vacancies can be filled up by the remaining Trustees with the approval and ratification of General Body of the Trust. The first nominee shall be given preference while filling such vacancy.










8) The general body of the Trust shall therefore consists of maximum 40 members and the meeting of the general body shall be convened, once in six months.

9) The investments of the Trust shall be in the forms and modes as directed in Section 11 (5) of the Income Tax Act 1961.

10) The Trustees shall frame separate rules and regulations or by-laws for the proper functioning of the Trust subject to the provisions of this Deed.

11) The Board of Trustees may raise funds necessary from the purpose of carrying out the projects of the Trust in the form of donation, deposits, grants, subsidy or loan or advance on such terms and conditions they may determine.

12) The funds of the Trust shall be held in account to be opened with a Scheduled, Nationalised or Co-operative Bank as may be decided by the Board of Trustees with the approval of the General Body meetings of Trustees.










13) All income from various institutions run by SVECT shall be held by the Trust subject to the powers, provisions and agreements hereinafter declared and expressed.

14) There shall be a Chairman, a Vice Chairman, a Secretary, a Joint Secretary and Treasurer and 6 members in the Board of Trustees who shall be elected by the General Body Meeting convened for the election of Board of Trustees.

15) There shall be separate Managers elected or appointed to each institutions run by the Trust.

16) The accounts of the Trust shall be jointly operated by the Chairman, Secretary and Treasurer and the accounts of the institutions run by the Trust shall be jointly operated by the Trust Chairman, Secretary and the concerned Manager.

17) The Secretary of the Board shall be the officer to convene both the meetings of Board of Trustees and General Body. The meeting of the Board of trustees shall be convened twice in a month. However the Chairman can convene General body meetings of Trustees on demand of atleast 60% of the live Trustees.

18) That the objects for which the Trust is established are:-

- (a) To establish, run, support and grant aid or other financial assistance to Schools, Colleges, Libraries, Universities, Laboratories for the use of students and general public.
- (b) To establish, develop, maintain and grant in cash or in kind to hospitals, medical institutions for the benefit and use of the general public.
- (c) To establish develop religious institutions, old age homes, hostels, orphanages, institutions for the physically disabled and mentally retarded persons.
- (d) To act as an agency of public utility services.
- (e) To undertake all other charity works as decided by the Board of Trustees for the uplift of the Poor and Agriculturists.
- (f) To undertake projects for the modern systems of Agriculture and Research in Agriculture with modern Agro Laboratory, Nursery and Herbal plants.
- (g) To promote Sports, Cultural activities and introduce scheme for the promotion of Sanskrit languages.
- (h) To evolve schemes for the welfare and uplift of women.
- (i) To acquire moovable and immovable property to fulfill the objectives of the above mentioned purposes.



19) The funds of the Trust shall be utilised for the aforesaid purpose and all income that is derived by the conduct of the institutions shall be utilized for the fulfilling of the objectives of the SVECT as provided by this Deed. The accounts of the Trust and the related institutions shall be duly audited by competent Chartered Accountant and placed before the Annual General Body meetings of the Trustees to ensure proper accounting of the Trust Funds.


20) The Board of Trustees shall in the administration of the trust, hereby frame act according to their unanimous decisions as far as possible and in case of difference, according to the opinion of the majority.


21) No Trustee shall continue in office on the same post not more than two terms consecutively except as members in the Board.


22) No Board of Trustee shall hold any office of profit or enjoy benefit from the Trust by any means other than actual expenses for conducting the regular duties entrusted to him.





